ITEM #1

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK OF PARAGOULD, ARKANSAS TO ATTACH LIENS TO CERTAIN PROPERTIES LOCATED AT THE ADDRESSES SPECIFIED IN THIS RESOLUTION FOR THE PURPOSE OF COLLECTING MONIES OWED THE CITY OF PARAGOULD FOR ENFORCEMENT OF CHAPTER 18 OF THE CITY'S CODE OF ORDINANCES

POLICE DEPARTMENT – MONTHLY REPORT

Mayor Gaskill told the council that for the month of August the police department took 1503 incident reports, made 391 arrests (347 misdemeanors, 35 felonies and 9 DWI), wrote 388 traffic tickets and worked 72 accidents. The report noted 66 felony cases were opened.

ITEM #3

FIRE DEPARTMENT – MONTHLY REPORT

Mayor Gaskill told the council that for the month of August the fire department answered 12 fire calls, responded to seven citizen complaint calls and 5 public assist calls, issued 254 burn permits, made 38 business inspections, completed 770.75 training hours and made one educational visit.
