

POLICE OFFICER :

The City of Paragould is currently accepting applications for police officer. To be eligible for testing you must have a current application on file. Applicants must also meet the following requirements established by the Arkansas Commission of Law Enforcement Standards:

- Applicant must be at least twenty-one (21) years of age.
- Applicant must have a high school diploma or GED certification.
- Applicant must possess a valid driver's license at the time of hire, with no record of suspension or revocation in any state.
- Applicant must have no felony convictions.
- Applicant must be of good moral character. A comprehensive background investigation will be conducted.
- Applicant will be required to pass a physical agility test and a written police officer selection test. Applicant will also be interviewed by an interview board.
- Applicant must be a citizen of the United States as of the date of the written test.
- Applicant must live within 35 minutes of the police station when hired.
- The City of Paragould will require a psychological and medical examination (including drug screen) after an offer of employment has been made to a job applicant and prior to the commencement of the employment duties of said applicant. Condition of employment is dependent on results of said exams.

When returning completed applications, a résumé must be attached. Once the testing date is finalized, all current applicants will be notified.

E911 DISPATCHER:

The City of Paragould is currently accepting applications for the position of E911 Dispatcher. Must be available to work any shift. Applicants must meet the following requirements:

- Graduation from a high school or GED equivalent with specialized course work in general office practices such as typing, filing, accounting or bookkeeping.
- Two (2) years of increasingly responsible related experience, or any equivalent combination of related education and experience.
- Minimum age of 18.
- No felony and/or class A misdemeanor convictions.
- Successful completion of background investigation.
- The City will require a medical examination and drug screen after an offer of employment has been made to a job applicant and prior to the commencement of the employment duties of such applicant and will condition an offer of employment on the results of such examination.
- Certificate on ACIC Terminal Operations (obtain within first six months of employment).

When returning completed applications, a résumé must be attached.

SANITATION LABORER:

The City is currently accepting applications for the position of Sanitation Laborer.

- Applicant must have a high school diploma or GED certification.
- Applicant must possess a valid Arkansas driver's license at the time of hire.
- Applicant must be a citizen of the United States as of the date of the written test.
- The City of Paragould will require a psychological and medical examination (including drug screen) after an offer of employment has been made to a job applicant and prior to the commencement of the employment duties of said applicant. Condition of employment is dependent on results of said exams.
