**ITEM #1**

**AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF PARAGOULD, ARKANSAS. APPLICATION OF TROY AND LEAH GRAMLING; PROPERTY LOCATED IN THE 2900 BLOCK OF FAIRVIEW ROAD**

Motion made that the ordinance be offered by Councilmember Biggs; seconded by Councilmember Gibson.

Troy and Leah Gramling are requesting this property be rezoned from AG to R-1 to develop a subdivision. Adjoining property owners William Watson, Kayla Cole, Karen Cooper, Donald Cole, Coleman Rothe and Matthew Bryant all spoke in opposition of this rezone because of flooding and drainage issues. Mr. Gramling appeared and stated that he understands the concerns. He states that with his proposal he intends to make the drainage in the area better. He stated that he feels their concerns will be eased when they can see the plans.

## **ITEM #6**

### **VECTOR DISEASE CONTROL REPORT**

A report provided by Vector Disease Control stated that for the month of May, 2019 VCDI has utilized six light traps placed in residential and recreational areas throughout the city. The traps collected an average of 1.3 mosquitos per trap night. Fifteen areas were inspected for larval mosquito breeding and none of those sites had larval present. VCDI applied adulticide on seven truck nights spraying a total of 254 miles (9235.1 acres) using a total of 54.5 gallons of adulticide. VCDI had no service request and adulticided all parks and any special events during the month of May.

### **ANNOUNCEMENTS:**

Mayor Gaskill stated that next week, due to the Fourth of July holiday falling on Thursday, Thursday's trash will be picked up on Wednesday.

Mayor Gaskill told the council that the pot hole truck is here. Street department employees trained on using the truck last week and have now begun fixing pot holes.

Mayor Gaskill reminded the council that bid opening for the new fire station will be tomorrow, June 25<sup>th</sup>, at 2 p.m. in the council room.

Mayor Gaskill congratulated City Clerk Andrea Williams for being named Arkansas City Clerk's, Records and Treasurers Association Clerk of the Year.

Mayor Gaskill shared with the council that ChamberofCommerce.org has named the City of Paragould #9 on their list of Best Cities to Live In in Arkansas 2019.

Mayor Gaskill asked Councilmember Biggs to give the council a report on the A & P Commission. Councilmember Biggs stated that the commission met last Thursday night and awarded four applications: \$1,500 to the Greene County Historical and Genealogical Society for its 10<sup>th</sup> annual Heritage Fair; \$11,500 to the Greene County Future Fund for entertainment for the Get Downtown festival; \$2,470 to Paragould Youth Baseball to fund the 12 year-old Cal Ripkin State Tournament; and \$50,000 for five years to the Power Plant project contingent upon the committee raising another \$500,000 this year. Councilmember Biggs stated the commission is now taking applications for the next set of grants to be awarded in August.

There being no further business to come before the council, Councilmember Biggs moved the meeting be adjourned; seconded by Councilmember Williams. All in favor. Meeting adjourned 6:57 p.m.
