Notice of the public hearing shall be published in a newspaper of general circulation in Paragould, not less than ten (10) days prior to the date of said hearing. The public notice shall give the particular location of the property and the type of use for which the permit is requested. Proof of publication is to be filed in the City Clerk's office.

AND

Notice of public hearing shall be given to adjacent property owners and owners of property located across any streets from the subject property by certified mail at least ten (10) days prior to the public hearing. Applicants must show proof of certified mail, receipt or refusal.

## CHECKLIST

### 10 DAYS OR MORE PRIOR TO MEETING

\_\_\_ Publish Notice of Public Hearing once in a newspaper of general circulation in the City. Notice must be signed by a City Inspector. (Notice attached)

\_\_\_ Notify surrounding land owners by certified mail – return receipt requested.

\_\_\_ Map of subject property with surrounding land uses, addresses and owners. Map must be sent to commissioners and city inspectors.

\_\_\_ File application containing explanation of request along with an original map with the City Clerk.

\_\_\_ Notice must be given to all commissioners and city inspectors.

\*\*\*\*See Planning Commission List\*\*\*\*

(These do not have to be certified mail, but must reach commissioners and city inspectors 10 business days prior to the meeting.)

### FRIDAY BEFORE MEETING ON THURSDAY

\_\_\_ Make copies of returned certified mail receipts and proof of publication. File originals with City Clerk.

\_\_\_ Filing fee must be paid to the City Clerk. Filing fee is \$25.00
